Please consider or re-consider this opportunity. Our association depends on you!





#### Student Aid Index Modeling Tool available -

Instructions for using the tool, a sample of the tool, and the Excel workbook are available for download. Please read the instructions before using. This tool is intended to allow institutions to model how the recent changes to the EFC formula (converting to SAI) will impact student need and Pell Grant awards. The tool uses provisions from the FAFSA Simplification Act, with the exception of the new requirements to include small businesses and family farms as assets (as those items are not reported on the FAFSA currently to compare).

Each of the six larger petals represents a public university within the regents' system—Black Hills State University, Dakota State University, Northern State University, South Dakota Mines, South Dakota State University, and the University of South Dakota.

The two smaller petals are a nod to the two schools within the system that serve special K-12 populations: South Dakota School for the Blind & Visually Impaired and South Dakota School for the Deaf.



## Higher education marketing campaign launched in South Dakota

In a cooperative effort with the six public universities, the South Dakota Board of Regents launched the marketing campaign, "Learning Drives us Forward," to highlight the value and importance of higher education.

"The purpose of this campaign is to show that industry leaders are grown right here in South Dakota, specifically at our public universities," said Regent Jim Thares. "It tells the real story about South Dakota's public universities—one of economic impact and workforce empowerment that pays off today and tomorrow."

"We are highlighting the good work done at our universities and the importance of higher education to the state," said Brian L. Maher, the regents' executive director and CEO. "At a time when universities throughout the Midwest are competing for students, it is more important than ever to remind people of the great opportunities our universities offer."

The "Learning Drives Us Forward" campaign, developed by Lawrence and Schiller Marketing and Advertising of Sioux Falls, began earlier this year with a budget of \$160,000. Each of the universities will share in the cost of the campaign with the Board's central office.
